ORDINANCE 98-16

AN ORDINANCE TO AMEND ORDINANCE 97-5 CONCERNING THE ORDERLY CUTTING OF TREES AND REMOVAL OF DEBRIS, TO PROVIDE FOR PERMITS TO CUT TREES BY ANY TWO COUNCILPERSONS AFTER PHYSICAL INSPECTION, TO PROVIDE FOR A PENALTY OF NOT LESS THAN \$100.00 NOR MORE THAN \$250.00 FOR EACH TREE CUT, TOPPED, OR TRIMMED WITHOUT A PERMIT, TO PROVIDE FOR A PENALTY OF NOT LESS THAN \$50.00 NOR MORE THAN \$100.00 PER DAY FOR FAILURE TO TIMELY REMOVE DEBRIS, TO PROVIDE THAT ALL TREES TO BE CUT, TOPPED, OR TRIMMED TO BE CLEARLY MARKED BEFORE INSPECTION, TO PROVIDE THAT PERMITS SHALL EXPIRE THIRTY DAYS FROM DATE OF ISSUE, AND TO PROVIDE THAT TREES LOCATED ON THE GOLF COURSE OR SKI SLOPES ARE EXEMPT FROM THE PROVISIONS HEREOF.

The Council of the City of Sky Valley hereby ordains:

(1) Section 2. of Ordinance 97-5 is hereby amended by striking the words “any one councilperson” and inserting after the word “by” the words “any two councilpersons after a physical inspection has been made” so that as amended the section will read as follows

“2. No trees measuring eight (8) inches or more in diameter at eighteen (18) inches above ground level may be cut down, removed, trimmed or topped without the written approval of the Tree Removal Committee, unless located within fifteen (15) feet of the owner’s main dwelling or accessory building or within fifteen (15) feet of the approved site of such buildings, driveways, septic tanks or parking areas. Written approval shall be issued by any two councilpersons after a physical inspection has been made, without approval of the Tree Cutting Committee, if all the guidelines established and provided for by this ordinance are met.”

(2) Section 4. is hereby amended by striking the amount “\$250.00” and inserting in its place the words “not less than \$100.00 and not more than \$250.00”.

(3) Section 9. is hereby amended by striking the words “\$100.00 per day.” and inserting in their place the words “not less than \$50.00 per day and not more than \$100.00 per day.”

(4) Section 10. is hereby amended by replacing it in its entirety with the words: “10. All trees to be topped, trimmed, cut, or removed shall be clearly marked before the physical inspection is made.”

(5) Section 11. is hereby added as follows:

“Permits for the cutting, topping, trimming, or removal shall expire thirty (30) days from the date of issue.”

(6) Section 12. is hereby added as follows:

“12. Trees located on the golf course or ski slopes are exempted from this ordinance.”

(7) Section 13. is hereby added as follows:

“The effective date of this ordinance shall be Nov. 4, 1998.”
