1. Call to Order

Mayor MacNair called the meeting to order.

2. Adoption of Agenda

Councilor Wheeler made a motion to adopt the agenda, seconded by Councilor Howard, unanimously approved.

NEW BUSINESS

3. Discussion for the 2020 Budget

City Manager Fast was asked to lead the discussion, on the revision, for the 2020 proposed budget. Recommendation for lowering the millage rate to 15.608 brought on some changes to the budget.

Revenues

By lowering the millage rate would result in a reduction of \$29,081 in revenues and a 3.10% tax reduction.

Possible increase on interest of \$5,000 – by having two \$250,000, Certificate of Deposits.

Administration

A correction on Administration Regular Salaries was made along with reducing Health Insurance by \$6,188.

Buildings and Grounds

Reduction for Electricity by \$2,000 to \$13,000

Police

Reduced Temporary Employees by \$2,000 to \$5,000, Health Insurance by \$16,234 to \$25,766 and Workers Compensation by \$3,837 to \$16,531.

Fire

Correction made, \$88,294

Roads

Salaries include the promotion of Jerry Shope as Assistant Public Works Superintendent and reduced Health Insurance to \$18,586, Repairs and Maintenance by Others to \$20,000 (hopefully the new equipment will offset the cost of repairs by \$10,000)

Special Events

Technical Services reduced by \$2,500 (Fireworks)

Which brings the total reduction in the General Fund budget to \$24,431

Questions from Council and the audience were answered by City Manager Fast, Public Works Superintendent Holbrooks or other Council members. Outside of budget questions and/or comments were two questions concerning an ordinance, addressing the encroachment of right of ways in the City and how to view minutes or videos on the City's website. Both questions were addressed by City Manager Fast and Police Chief Estes.

OTHER BUSINESS

4. Adjournment

There being no further business to come before Mayor and Council, Councilor Wheeler made a motion to adjourn, seconded by Councilor Howard, unanimously approved.

The meeting adjourned at 11:02 a.m.
